**NOTICE INVITING APPLICATIONS FOR THE POST OF CHAIRPERSON OF SIKKIM
ELECTRICITY REGULATORY COMMISSION**

In Accordance with Section 84, 85 & 89 of the Electricity Act 2003, Government of Sikkim invites applications for the post of Chairperson, Sikkim Electricity Regulatory Commission (SSERC) from persons who meet the following Criteria:-

1. The person shall be of ability, integrity and standing who has adequate discerning knowledge of and has shown capacity in dealing with problem relating to engineering, finance, commerce, economics, law or management.
2. The person should not have any financial or other interest with any corporate entity dealing with Generation, Transmission, Trading and Distribution of electricity in Sikkim which is likely to affect prejudicially his or her function as Chairperson of the Commission. The person must give a certificate to this effect while applying for the post.
3. The Chairperson shall hold Office for a term of 5 (five) years from the date he enters upon his office or till he attains the age of 65 (sixty five) years, whichever is earlier.
4. The terms and conditions of Service of the Chairperson will governed by the Gazette Notification dated 29.11.2011 as notified by the Government of Sikkim vide No. 618 dated 29.11.2011 as amended from time to time.
5. The Selection Committee constituted as per the provision of the Electricity Act, 2003, for the purpose of making the selection to the post of Chairperson, reserves the right to consider and recommend any other person fulfilling the criteria laid down in the Act for the post of the Chairperson apart from those who have applied against this advertisement. The Head Quarter of Sikkim State Electricity Regulatory Commission will be at Deorali, Gangtok.
6. Suitable candidates with adequate qualification and requisite age as prescribed above may apply with their Bio-data mentioning their age, qualification, experience, present status etc within 4.30 pm of 15.04.2021 to PCE-cum-Secretary, Power Department, Government of Sikkim, Gangtok, Pin No. 737101 with the envelope superscribed "Application for the post of Chairperson SSERC.
7. The applicants in Government Service should apply through proper channel.
